1 - É criada uma "light fitting zone" (LFZ), na mesma zona do RZ 4, para a qual as equipas poderão ter a ajuda de 2 mecânicos, que no entanto não poderão proceder a outra qualquer forma de assistência, de acordo com o Art. 52.6 das 2018 FIA RRSR:

1 - A "light fitting zone" (LFZ) was created, in the same zone as the RZ 4, for which the teams can have the help of 2 mechanics, but they can not use any other form of assistance, according to Art. 52.6 of 2018 FIA RRSR:

52.6 LIGHT FITTING ZONE (LFZ)

At each light fitting zone:

- No work is allowed within the marked zone other than for two-team personnel to fit or remove auxiliary lights, using hand-held tools and under the supervision of rally officials at all times.
- The two-team personnel may enter the zone only after their respective car has entered the time control and must leave immediately after the auxiliary lights have been fitted or removed.
- The extra lights and tools to fix or remove them may be transported to and from the zone in a service car.
